Preferences are offered to tenderers who meet the following criteria:

- CIDB Grade 3GB/CE/EB to 5GB/CE/EB
- Women/Youth/ People living with Disabilities owned Companies
- Companies with existing offices in KZN

Only tenderers who meet the following requirements will be eligible for further evaluation;

- Proof of Active CIDB registration - Grade 3 to 5 GB/CE/EB
- Women/Youth/People with Disability Company Ownership
- Companies with existing offices in KZN

Mandatory Returnable Documents

- Completion of SBD 1, 4, 6.1 in full
- Declaration that information on CSD is correct and up to date
- Proof of existing company offices in KZN; e.g. Municipal Bill, Rental Agreement, proof of ownership etc;
- Proof of Central Supplier Database (CSD) registration (consolidated for Joint Venture Partners)
- Copy of the certified valid tax clearance with Tax Compliance Pin certificate (TCC)
- Copy of the Joint venture agreement signed by both parties (where applicable including apportionment of the JV)
- CIPC Document
- Valid Letter of Good standing i.e COIDA Certificate from DOL / RMA / FEM (Companies without staff must submit letter from the Department of Labour in place of COIDA certificate)
- ID Document for evidence of Women & Youth Ownership
- People with Disability to Letter from the Dr. Confirming the Disability;
- Proof of company experience
- CV and Certified Qualification of Key Personnel

Note: (i) Failure to submit any of the above documents / requirements shall result in immediate disqualification of the bid.
(ii) Failure to complete and sign any designated spaces in the bid document shall result in immediate disqualification of the bid.
(iii) If any of the Directors are listed on the Register of Defaulters, it shall result in the disqualification of the bid
(iv) If any of the Directors are in the employment of the State, it shall result in the disqualification of the bid.

- (i) Contractors who will be approved on the panel will only be invited for the work within their CIDB Grade during request for quotation process
